6.3 Methods for containment and cleaning up

Place spilled material in a designated, labeled waste container. Dispose of via a licensed waste disposal contractor.
Large spill	:	Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Avoid dust generation. Do not dry sweep. Apply "Dust Bane" to the spill in order to minimize airborne particles . Carefully consolidate spilled powder using rubber floor squeegee or shovel so as to minimize airborne particles. Treat remaining residue as Minor Powder Spill or Vacuum dust with equipment fitted with a HEPA filter and place in a closed, labeled waste container.
